

## **TECHNICAL DATA SHEET**

# **CERAMIC FIBRE ROPE**

Braided packing of square or round cross-section, made of ceramic yarn reinforced with inconel. Maximum permanent operating temperature of 1260°C. The surface of ceramic fibre rope braided packing should be free of damage, thickening and overstraining as well as sticking out broken threads. The packing should not delaminate and crack.

#### SCOPE OF APPLICATION

Aluminosilicate packing is used as a sealing material for machine and equipment components at temperatures up to 1260°C. The material does not contain flammable agents, is resistant to water, steam, oils and dry gases in the pH range of 5-9.

# APPLICATION

Sealing of boilers, coal mills, industrial furnaces, furnace doors, flaps, covers, thermal insulation of heat pipes and others.

PACKING, STORAGE, TRANSPORT, DISPOSAL

The packing should be placed in bags or cardboard boxes. Store in conditions which prevent contamination and destruction. The packing material is not hazardous, does not contain asbestos, formaldehyde and phenolic derivatives. They may be stored in industrial waste dumps; no special conditions are required. Properly selected, stored, assembled and operated packing do not pose any danger. Use protective gloves during assembly. There are no other hazards.
